
SLD.th .TH SECOND-LEVEL DOMAIN REGISTRATION, ROUND 2/2026

The **THNIC Foundation** has instituted a policy to open three rounds annually to register **.th second-level domain names (or SLD.th)**. Round 2 for 2026 is about to commence.

Objectives

The establishment of the SLD.th registration scheme is designed to mobilize financial resources in support of national internet development. Proceeds from domain name registrations and renewals will be allocated to the THNIC Academy's programs that promote human resource development through capacity-building initiatives as well as advance Thailand's internet infrastructure.

Successful applicants must proceed with payment of annual donation for domain name registration and renewal. Failure to complete the payment will be considered as a waiver of rights for the domain name by the THNIC Foundation. The review process may be extended if the requested domain name is deemed to fall within the category of special terms.

11 August - 11 September 2026

Disputes accepted. Dispute filing fee: 20,000 Baht per one domain name
