Subject .TH Second-Level Domain Registration, Round 2/2562 B.E. (2019 C.E.)

According to THNIC has announced policies to offer .th second-level domain (or .th SLD) on an annual basis, which will provide services in a limited time period in three rounds per year. Presently, THNIC is ready to offer the 2nd round of year 2019 with following details:

1. Objectives

All fees receiving from domain name registration/renewal will be funding to projects aiming to develop the Internet infrastructure for public benefits in Thailand.

2. Policies and Guidelines

Refer to policies and guidelines for .th second-level domain name registration, revised May 2019 C.E.

3. Registrar Service Provider

THNIC has authorized the Registrar which is T.H.NIC Co., Ltd. to provide services of .th SLD registration. Users can reach them at following contacts:

4. Services Period

- .Open for applications on 1 August 2019 C.E. at 9.00 a.m. (local time).
- Deadline to applications and send supporting documents or proof of application fee payment on 30 September 2019 B.E. at midnight (local time).
- Submit applications online at the Registrar website (<https://thdomain.thnic.co.th>)

5. Fees and Payments

5.1. Application Fees

- Total amount 10,000 Baht (Ten Thousand Baht only) per 1 domain name. VAT is included.
- Payable to **T.H.NIC Co., Ltd.** as following payment channels:
 - (1) Account no. 130-3-00550-1 (current) Siam Commercial Bank, Ratchawat branch; or
 - (2) Account no. 178-2-66467-7 (saving) Kasikorn Bank, Klong Luang branch; or

5.2. Annual Domain Name Registration/Renewal Fees

- Total amount 100,000 Baht (One Hundred Thousand Baht only) per one domain name per one year.
- Payable to **Thai Network Information Center Foundation**. Account no. 406-000919-5 (saving) Siam Commercial Bank, Thammasat Chalermprikiat Hospital branch.

6. Application Verifications and Result Notifications

The Registrar will filter all applications attached with supporting documents and proof of application fee payment (see payment details in clause 5.1); and will post the domain names specified in those applications on 1 October 2019. Then, the .th SLD application verification committees who are appointed by THNIC will proceed the verification process during 1-7 October 2019 C.E. and the Registrar will announce the approved domain names on 8 October 2019 C.E. at <https://www.thnic.co.th/sld/>.

Successful applicants can proceed to pay registration fee as details specified in clause 5.2. In the event that a user do not complete payment or any incomplete payment, THNIC will consider it a waiver of rights in domain name.

7. Dispute Reception Period

- Open to receive disputes on 8 October 2019 C.E.
- Deadline to receive disputes on 8 November 2019 C.E.
- Dispute filing fee, total amount 20,000 Baht (Two Thousand Baht only) per one domain name. See payment details in clause 5.2
